

**SASFAA Executive Board Meeting  
Conference Call – Nominations and Elections  
November 1, 2000**

**CALL TO ORDER**

President Bill Cox called the SASFAA Executive Board to order at 3:05 PM on Wednesday, November 1, 2000. The board meeting was conducted by means of a conference call.

**PURPOSE OF BOARD MEETING**

The meeting was called to hear the report of the Nominations and Elections Committee and act upon their recommendations.

**NOMINATIONS AND ELECTIONS COMMITTEE REPORT**

Mary Givhan, chair of the Nominations and Elections Committee, indicated that the committee met October 9-10, 2000 in Atlanta to consider candidates for the position of President-Elect, Vice President and Treasurer. The treasurer will serve a two-year term. As a result of that meeting, the following candidates were presented to the SASFAA board for consideration as the slate of officers:

Candidates for two-year term as Treasurer: Terry Bland of BancorpSouth Student Loans (Mississippi) and Sonja S. McMullen, Sallie Mae, Inc. (Tennessee)

**Action: Rose Mary Stelma moved to accept the slate for the officer of treasurer. The motion was seconded by Karen Koonce and approved.**

Candidates for Vice President: Ron Day, Birmingham Southern-College (Alabama) and Ellen Green, Charleston Southern University (South Carolina).

**Action: Karen Koonce moved to accept the slate for the officer of vice president. The motion was seconded by Gary Mann and approved.**

Note: Karen Koonce was not involved in the remainder of the conference call.

Candidates for President-Elect: Karen Koonce, Tidewater Community College (Virginia) and William (Bill) Spiers, jr., Tallahassee Community College (Florida).

**Action: Nancy Roberts moved to accept the slate for the officer of president-elect. The motion was seconded by Darolyn Porter and approved.**

The Chair of the Nominations and Elections Committee, Mary Givhan, indicated that the committee had tried very hard to identify and propose minority representation for the slate of officers. The committee put forth a concerted effort to solicit individuals to run for SASFAA elective office, but they were unsuccessful in doing so. She indicated that she planned to attend the HBCU session as well as the Diversity Concerns breakfast at the annual conference to discuss the need for minority involvement in the SASFAA leadership positions.

**Action: Mary Givhan moved to adjourn the board meeting at 3:30 PM. The motion was seconded by Sandy Neel and was approved.**
