Good morning SASFAA Board,

Things are moving right along in this SASFAA year and it's time to set our sponsorship packages so Dewey can begin advertising and soliciting vendors, specifically as it relates to conference support. Pursuant with Section 7.1 of the P&P Manual (see below) I am sending notice to the Board for an E-Meeting to be held on Monday, October 24<sup>th</sup>, to vote on the attached sponsorship proposal. The meeting will begin at 9:30am. According to Section 7.1.1 there is no second needed to hold this meeting since it is being called by the President.

Monday at 9:30am I will send a notice to the board calling the meeting order and restating the motion. The motion in this case is we have a recommendation from the Sponsorship Committee to approve the attached SASFAA Exhibitor/ Sponsorship Options for 2011-12.

After the meeting is called to order the SASFAA elected officers and state presidents will need to hit "reply all" indicating their presence and offering any discussion. There are 15 voting members of the board. According to the By-Laws 3/5's of the voting members need to indicate their presence in order for us to hold the vote (9 of the 15 voting members). As soon as we have at least 9 indicating their presence I will declare a quorum and call for the vote.

Once I have called for the vote the voting members of the board will need to hit "reply all" again and cast their vote for (yea) or against (nay) the motion. 24 hours after that point (or earlier if everyone votes before 24 hours expire), I'll declare the motion passed or failed.

One final note. Since this is an E-Meeting you don't have to be sitting at your computer from 9:30 - 10 or 10:30. Voting members, as soon as possible after I call the meeting to order at 9:30 please get a computer to indicate your presence. Presence in this case does not mean you are sitting at your computer for an hour. It just authorizes us to move forward with the discussion (should people wish have e-mail discussion) and the vote once at least 9 of the 15 voting members response.

I'm sorry for the short notice, but we want to begin soliciting sponsors no later than the week of the 31<sup>st</sup>, which is why we need to act on this Monday. Committee chairs, even though you do not have a vote and do not need to respond indicating your presence, feel free to respond with any questions or comments during the discussion period should you have any.

# Section 7.1: Meetings

### Policy for E-Meetings of the SASFAA Executive Committee

1. A member of the Executive Committee wishing to present a motion shall request the President to call an emeeting. If the President wishes to call a meeting, he/she may do so without the need for a motion and a second.

2. The President will send notice of the motion to the Executive Committee. A member of the Executive Committee must second the motion in order for an emeeting to be called.

3. Notice of an e-meeting will be sent by the President to the Executive Committee (and others on the board, when appropriate), a minimum of 24 hours prior to the opening of the meeting, telling the time and day the meeting will be Called to Order, as well as restating the motion and fact that it has been seconded.

4. Once the e-meeting has been Called to Order and a Call for Discussion is made, members of the Executive Committee will "reply all" indicating their presence and offering any discussion.

5. When the majority of members of the Executive Committee have indicated their presence and offered discussion, or when 48 hours has elapsed from the Call to Order(whichever is earlier), the Chair will declare a quorum and call for the vote.

6. Members of the Executive Committee will "reply all" with their vote within 24 hours of the call for the vote.

7. After 24 hours from the call to vote, the Chair will declare the motion passed or failed and adjourn the meeting.

8. The Secretary will preserve all emails stating presence, votes, and disposition, and file same with the original copy of the minutes of the called meeting.
