• Budget and Finance Policy Updates

Marian Dill summarized a recommendation from the committee for changes to accommodate e-signatures – there was no discussion; motion carried external audit – the last audit was in 2019. The cost is \$6,800; motion carried legal and accounting fees exceeded the budget, but investment income and expense exceeded

Long Range Plan

Keith Reeves summarized the activity for the year and explained the focus of previous surveys, and the change in relevance based on the experiences of the past year. He recommends

- o a full review of the LRP by the incoming board prior to the start of the year
- o inclusion of time commitment statements which the incoming president would review with committee chairs and the nominating committee review with candidates
- o Board Governance Committee
- Finance
 - eliminate Treasurer-elect position and hire Bookkeeper
 - standardize external reviews and complete every two years
- Congressional Hill Visits
 - Conduct "when needed"
 - Not annually due to cost factors
 - Visits are not lobbying, they are informational

The motion to accept plan carried.
